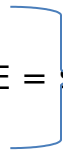

Commercial Vendor and Non-Profit Display Rental Space

The Cheboygan County Fair is gearing up! We are inviting you to participate at this year's fair, along with other new vendors and exhibitors. The Cheboygan County Fair has been rated as an Award Winning Fair in the State of Michigan by the Detroit News. We are very excited to have the Skerbeck Bros. Show, Inc. back as our carnival. They are also part of the UP State Fair Carnival. The carnival will be set up and running Tuesday through Saturday. We are also offering the petting zoo again this year, which will run Monday through Saturday.

Advertise and sell your products to over 35,000 fair visitors!

We ask that all exhibitors and vendors be set up no later than 3:00 pm Sunday. Early set up can be arranged for Friday by appointment with the Fair Office (231) 627-7051.

Exhibitors and vendors must provide their own backdrops and tables. Payment in full is expected before set up date.

We are continuing the same low rates with no extra fee for electricity.

Unacceptable merchandise not allowed to be sold at the fair include: knives, switch blades, brass knuckles, nunchucks, pictures and photographs of nude or partially nude people, or any other merchandise deemed harmful or distasteful to oneself or others. We will not allow any loud music or noise that interferes with other vendors inside or outside of the building. These regulations will be enforced and closely monitored by the Cheboygan County Fair Board. Failure to adhere to this policy may result in your being asked to leave the fairgrounds and automatically forfeit your space and rental fees. Cheboygan County Fair Board and Management will use the utmost diligence to ensure the safety of livestock and articles entered for exhibition and display after their arrival on the grounds. Under no circumstances will the Cheboygan County Fair be responsible for loss or theft, or damage by fire, lightening, wind or other acts to such livestock or articles on exhibition or display. The signer or representative of the commercial rental space contact shall hold Cheboygan County, Cheboygan County Commissioners, Cheboygan County Fair Board and Management harmless and indemnified.
